**Inviting applications from ITI passed/ITI examination appearing/ H.S.C. (MCVC) passed candidates and S.S.C. passed candidates for filling in posts of Trade apprentices for August, 2010 recruitment session under the Apprentices Act, 1961**

Applications in the prescribed forms are invited from ITI passed/ITI examination appearing candidates for the posts of Trade Apprentices in the trades of Mechanic (Motor Vehicle), Auto Electrician, Fitter, Turner, Welder, Motor Vehicle Body Builder, H.S.C. (MCVC) passed candidates in Mechanical Technology and Auto Engineering Technician subject fields in the trades of Fitter, Turner, Welder and Mech.MV and from S.S.C. passed candidates for the post of trade apprentices in the trades of Mechanic (Motor Vehicle) and Auto Electrician to be filled in the Transportation Engineering Department and from S.S.C. passed candidate for the post of trade apprentices in the trades of Ref. & Air Conditioning Mechanic and Cable Jointer and from I.T.I. passed/I.T.I. appearing candidates for the post of trade apprentices in the trades of Electrician, Wireman and Cable Jointer in the Electric Supply Branch of the B.E.S. & T. Undertaking for the August, 2010 session under the Apprentices Act, 1961.

**Requirements: For ITI passed/ITI examination appearing candidates.**

Passed S.S.C. Examination with Maths and Science as subjects plus completed full time I.T.I. course in the respective trade and passed the final trade test. For M.V.Body Builder trade passed S.S.C. examination with Maths and Science as subjects plus completed I.T.I. course either in Forger and Heat Treator or Sheet Metal Worker trade and passed the final trade test. For Cable Jointer trade, passed S.S.C. examination with Maths and Science as subjects plus completed I.T.I. course in Wireman trade and passed the final trade test. Similarly for Auto Electrician trade, passed S.S.C. examination with Maths and Science as subjects plus completed I.T.I. course either in Mechanic (Motor Vehicle) or in Electrician trade and passed the final trade test.. Candidates appearing for the final trade test of I.T.I. examination in July, 2010 can also apply but if selected, the appointment will be subject to their producing the I.T.I. final trade test passing certificate.

**For H.S.C. (MCVC) passed candidates.**

Passed H.S.C.(MCVC) Examination in Mechanical Technology and Auto Engg. Technician subject field in the trades of Fitter, Turner, Welder and Mech.MV.

**For S.S.C. Examination passed candidates**

Passed S.S.C. examination with Maths and Science as subject with minimum 50% aggregate marks. In case of Scheduled Caste, Scheduled Tribe, Denotified/Nomadic Tribe candidates, 5% relaxation in S.S.C. marks will be given.

**Essential**

Knowledge of Marathi is essential. The candidate should have passed S.S.C. or equivalent or higher level examination with Marathi Subject (Higher or lower level) of 100/50 marks.

**p.t.o.**

- Age** : Between 17 to 22 years for I.T.I./ H.S.C. (MCVC) passed candidates and 15 to 20 years for S.S.C. passed candidates as on 2/8/2010.
- Period of training** : One/two year/s in case of I.T.I. passed/H.S.C.(MCVC) passed candidates and Two/Three years in case of S.S.C. passed candidates depending on the trade allocated.
- Stipend** : As prescribed under the Apprentices Act, 1961.

It shall not be obligatory on the part of the Undertaking to offer any employment to the passed out trade apprentice on completion of period of apprenticeship training.

Selected candidates will have to enter into Apprenticeship contract for training. Certain number of posts are reserved for candidates belonging to Scheduled Castes, Scheduled tribes, Denotified/Nomadic Tribes and sons of Ex-Servicemen, as per the provisions of the Apprentices Act, 1961. Candidates belonging to Scheduled Castes, Scheduled Tribes, Denotified/ Nomadic Tribes should attach certified [zerox] copies of caste certificates obtained from Competent Authorities along with their application, sons of Ex-Servicemen should attach certified copy of evidence of their parent being Ex-Servicemen.

Candidates fulfilling the above requirements should obtain their application forms (**From 23/06/2010 to 06/07/2010**) on payment of Rs.25/- in person from Monday to Friday [Timings: 10 AM to 12 Noon and 1.30 PM to 3.30 PM] from the office of the Superintendent (Training), Technical Training Centre, Wadala Bus Depot, Mumbai - 400 031, on producing their S.S.C. marksheet, School Leaving Certificate and I.T.I. certificate in case of I.T.I. passed candidates, H.S.C.(MCVC) examination mark-sheet in case of H.S.C.(MCVC) candidates and S.S.C. examination mark-sheet, School Leaving Certificate in case of S.S.C. passed candidates and should submit the application in person duly filled in on or before **6<sup>th</sup> July, 2010.**

Other detailed information will be exhibited on Notice Boards at Technical Training Centre, Wadala at the time of issue of application forms.

No information nor any application shall be given or accepted by Post.

No travelling or other expenses will be borne by the Undertaking.
