Sub Stations (DSS) such as switch gears and transformers are carried out by this dept. The HV and LV network is maintained in such a way that a reliable supply of electricity is ensured and there are minimum nos. of interruptions and quick restoration of electric supply whenever there is an interruption.

This shall include the responsibility for the smooth and uninterrupted working of:

- i. Receiving Sub Stations
- ii. Distribution Sub Stations
- iii. H.V. and L.V. mains

4 (b) (ii) : The powers and duties of its officers and employees :-

1. The powers and duties of Divisional Engineer :-

The Divisional Engineer shall be directly responsible to the Deputy Chief Engineer Distribution (South) and is the Chief Executive Officer In-charge of the Operation & Maintenance (South) Division.

- i. To assist him in the performance of his duties, he is provided with necessary Staff as mentioned above in 4 (b) (ii).
- ii. Optimum utilization of man power for maintaining quality of work.
- iii. To constantly keep under review all the activities of the department and introduce as & when necessary any changes that will materially improve the efficiency of the department. All changes concerning policy, however, before being introduced are subject to the prior approval of competent authority.
- iv. To submit an "Annual Report" on the working of his department to the Deputy Chief Engineer.
- v. He shall be responsible for inspection of all important works in progress and maintaining continuity of supply in co-ordination with other co-related departments.
- vi. To enforce all regulations, Standing Orders, Safety Rules and other departmental and statutory rules, instructions issued from time to time.

- vii. To submit detailed reports of all major interruptions of supply of serious nature or any breakdown of plant or equipment or any other major changes in the System.

2. The powers and duties of Superintendents & Assistant Engineers :

- i. To assist the Divisional Engineer in the discharge of his duties.
- ii. They shall be responsible for smooth functioning of day to day activities of their respective sections like -
 - a) 110 KV Receiving Substations Manning and Maintenance section
 - b) 33/22 KV Receiving Sub Station Manning and Maintenance section.
 - c) R&M of Distribution Sub Station (DSS), Static -1 and Static -2
 - d) Permanent Repairs of cables.
 - e) HV supply restoration
 - f) LV supply restoration
 - g) Cable fault Testing
 - h) Auxiliary distribution Pillar Maintenance
 - i) Scheme preparation and execution
 - j) Fault Control
- iii. To prepare and execute detailed program of operation, maintenance and testing of plant, machinery, cables and other equipment entrusted to the department.
- iv. They shall be responsible for restoration of supply.
- v. To maintain discipline and efficiency in all sections and staff under them, investigate reports of irregularities by staff and make suitable reports and recommendations to the Divisional Engineers.
- vi. To submit reports to the Divisional Engineer.
- vii. To ensure proper training is imparted to their subordinates, trainee engineers, tradesman etc.
- xiii To ensure maintaining records related to JE bills, Reinstatement Charges ,and follow up with other Utilities like MCGM,MBPT ,Collector etc for the reconciliation of R.I Charges.
- Xiv Allotment of departmental vehicles to different sections as per their requirements.
- Xv Obtaining management sanction for purchasing new tools, equipments,materials and for Recruiting manpower.

3. The powers and duties of Dy. Engineers :-

- i) EHV and HV Supply Restoration and arranging EHV and HV outages.
- ii) Preventive and breakdown maintenance of Receiving Substation equipments.
- iii) Preventive and breakdown maintenance of Distribution Substation equipments.
- iv) Testing and locating underground cable faults.
- v) Arranging for repairing of underground EHV / HV / LV cable faults.
- vi) Maintenance of Service Positions, Auxiliary Distribution Pillars, LV Boards and Mini Pillars.
- vii) Maintenance of HV / LV Cable Networks, protecting them from overloading by giving load reliefs by preparing and executing new cable laying schemes.
- viii) Maintaining the attendance of lower staff working under him.
- ix) Ensuring Safety Rules, IE / MERC Rules, etc.
- x) Suggesting to the seniors the new jobs to be taken up for maintaining the supply system.
- xi) Arranging the inspection of Receiving and Sub station equipments by PWD ELECTRICAL INSPECTOR.

4. The powers and duties of Sub-Engineers :-

- i) Manning of 110 KV Receiving Substations.
- ii) LV Supply Restoration and arranging LV outages.
- iii) Manning of Fault Control.
- iv) Helping the Dy. Engineer in their above mentioned activities.
- v) To carry out the jobs assigned by his seniors.
- vi) To keep the inventory of the tools and equipments of the Department.

5. The power and duties of Charge Engineers :-

- i) Manning of 110 KV / 33 KV / 22 KV Receiving Substations.
- ii) Taking of LV Loads for preparing LV Load-sheets.
- iii) Cleaning and inspection of Distribution Substations.
- iv) Manning of Fault Control.
- v) Giving temporary supply in case of LV Distribution and Service faults.
- vi) Helping the Dy. Engineer / Sub-Engineer in their above mentioned activities.

- vii) To carry out the jobs assigned by his seniors.
- viii) Direct in charge of the workmen like Jointers, Fitters, Masons etc.

6. Duties of Draughtsman:-

- i. Preparing Scheme Plans.
- ii. Taking out sketches and plans of underground cables.

7. Duties of Assistant Administrative Officer :-

Assistant Administrative Officer (AAO) is responsible to the establishment of the department and working directly under Divisional Engineer. The AAO shall assist the Divisional Engineer :

- i. To maintain discipline of the administrative staff.
- ii. To maintain service record files of the officers & staff of the department.
- iii. To prepare Annual Confidential Report Forms of the Officers.
- iv. To draft letters & look after general correspondence.
- v. To reply to RTI letters in consultation with Divisional Engineer and other section in charge.
- vi. To prepare monsoon, fair & extended fair season proposals, if any
- vii. To prepare Establishment Schedule and budget estimate.
- viii. To check medical reimbursement bills.
- ix. To maintain the imprest cash, follow up for recoupment of imprest cash bills. Xerox bills, PWD Electrical Inspector's visit fees which are paid from Imprest Cash. Audited departmental purchase form upto Rs.5000/- is also paid from Imprest Cash.
- x. To obtain Management sanction for appointing Scavenger for temporary period and to ensure his timely payment.
- xi. To put up cases to Concerned Authority for initiating disciplinary action against the offensive staff.
- xii. To check statements of overtime, field duty allowance, incentive bonus, meal allowance, compensatory allowance.
- xiii. To check the documents for caste validity certificates, send the same to the respective authority and keep the records of the same.
- xiv. To check & sign the identification notes for payments for the officers & staff.
- xv. To guide Subordinates during their day to day work.
- xvi. To check the credit society loan forms & provident fund loan forms.

- xvii. To follow up various files put up for sanction.
- xviii. General supervision of all administrative work
- ix. To check MCA queries and reply.
- xx. To check Accident Report and take further action.
- xi. To send various statements as directed by various authorities.
- xxii. To keep record of Annual Maintenance Contract of Computer & Printer
- xxiii. To ensure optimum utilization of man power and maintaining quality of work. He may go out for outdoor work as and when required. During his outdoor visits/meetings/leave, he delegates his power to senior most subordinate.
- xxiv. Any other job assigned by the Divisional Engineer.

8. Duties of Sr. Stenographer (English) :

- i. To take printouts of daily email received and sent. To send email to other departments.
- ii. To take dictation and transcribe it on computer and give the required copies as per priority.
- iii. To type any written note given by any officer of the department as and when required.
- iv. To assist AAO and other Administrative Staff/officers during exigencies.

9. Duties of Supervisor:

- i. To supervise the work of Clerks, Shop Recorders in the department, assist the AAO in his day-to-day work and in replying MCA queries and maintaining registers, files pertaining to them.
- ii. Taking over notes of permanent & temporary staff/officers, reversions advices and other matters with the help of Establishment Clerk.
- iii. To assist AAO to prepare ACR forms, establishment variation & Budget work.
- iv. To assist AAO to co-ordinate and follow up various matters.
- v. To put up proposal for yearly Diary to Administrative Manager (ES) / MM department.
- vi. To maintain record of E-cr/dr Statement & E-job sheet.

10 Duties of Clerk /Shop Recorder :

- i. To keep record of lease agreement /substations lease rent bills/ property tax paid for DSS, to follow up lapsed lease agreement of DSS, to check estimates and maintain registers of new DSS & file the DSS papers and to prepare Outstanding Bill Memo.

- ii. To prepare bills of Vehicles or Equipment's hired.
- iii. To send monthly servicing report/statements of departmental vehicles.
- iv. To prepare bills for work done for outside parties and maintaining its record.
- v. To prepare energy meter reading statements of All Receiving Sub Stations & send to DEMS for billing purpose.
- vi. To prepare reinstatement bills & property tax bills, J.E. Bills of Scheme & Faults.
- vii. To make inward/outward dispatch entry in the respective registers, scrutinize outgoing papers.
Inward V.I.P. letters & Outside parties (Customers complaints) letters, sort out the letters and forward to Concerned Officer.
- viii. To prepare budget estimates & maintains its records.
- ix. To fill up Purchase Forms/follow up & maintain its record.
- x. To keep proper stock level & store material in proper manner to avoid wastage / damage.
- xi. To prepare monthly, yearly fair / monsoon season requirement /consumption statements.
- xii. To work on Sunday/Holiday in the stores in rotation with other Shop Recorders.
- xiii. To recoup clothing as per the requirement, maintain its record & to issue the staff.
- xiv. To withdraw material from Kussara Store required for R&M work of Department and to issue in the sub-stores.
- xv. To maintain record of Time Bound promotion.
- xvi. To issue & maintain record of lockers, tools to staff against permanent gate-pass.
- xvii. To send statements for payment of stitching allowance and washing allowance.
- xviii. To send monthly absentee memo of 'A' & 'B' grade Officer/staff and maintain leave record in the attendance register of staff and officers.
- xix. To dispatch Leave forms, Provident Fund forms, LTA/Encashment forms of staff & officers to STK/DIA, identification note of staff & officers for LTA, Encashment, PF loan payment.
- xx. To prepare Regular, Reliever Overtime statement & Sunday/Holiday working statements for obtaining management sanction and thereafter to send zerox copies of the same to respective Time Keeping Department for making the payment.
- xxi. To send monthly unpaid cards to Time Keeping Department.
- xxii. To prepare & maintain record of inventory.
- xxiii. To prepare the Meal Allowance & Compensatory Allowance & Incentive bonus statement.
- xxiv. To recoup Stationery/Material and issue to all the sections as per their requirement and maintain its record.

- xxv. To maintain the record of deputation, trainee engineers/tradesman & send monthly statement.
- xxvi. To issue monthly Khadi cloth/soap to officers/staff.
- xxvii. To fill up purchase forms of material, equipments required for sub-store & Static-II Section & arrange to procure the same.
- xxviii. To maintain register of Tender files & papers.
- xxix. To prepare attendance register from job sheets and audit it, payment sheet, identification slips, balance payment statement of casual labour.
- xxx. To prepare statement for various allowances like of hazardous allowance, field duty allowance, Distribution Loss etc.
- xxxi. To keep attendance & look after work of Scavenger & preparing of his monthly Salary voucher/bill.
- xxxii. To prepare statement of Festival Advance.
- xxxiii. To prepare record of Annual Maintenance Contract of PC & Printers.
- xxxiv. To prepare MCA Report, Fatal/Accident Report.
- xxxv. To maintain records related to OB memo, JE bills, Reinstatement Charges ,to follow with other Utilities like MCGM, MBPT ,Collector etc for the reconciliation of R.I Charges.
- xxxvi. To assist AAO and other Administrative Staff/officers during exigencies.

11. Duties of Sr. Jointer:

Making EHV cable joints and terminations.

12. Duties of Jointer:-

- i. To replace cut- outs and neutral link on live service cable whenever required.
- ii. To carry out HV,LV Cable joints and terminations.
- iii. Maintain the various tools and materials in his possession.
- iv. Pot heading and sealing of cables..

13. Duties of Jointermate :

- i. To help jointer and Senior jointer in their various activities.
- ii. To isolate LV cable faults.

14. Duties of Fitter :

- i. Preventive and breakdown maintenance of Receiving and Distribution Substation equipments such as circuit breakers, transformers, capacitors, reactors, current transformers, potential transformers etc.
- ii. To recondition pillars and LV Board etc.
- iii. Maintenance of various tools and equipments such as oil filtering machine, compressors, Fire fighting equipments etc.
- v. Carrying out Receiving and Distribution substation earthing job.

15. Duties of Muccadam :

- i. To take attendance of men working under him.
- ii. To supervise the gang of Nawghanies working on excavation, erecting pillars and cable laying, etc.
- iii. To ensure that obstruction to pedestrians and vehicular traffic is kept to the minimum by proper piling and stacking of debris and by providing suitable crossings across the trenches.
- iv. To arrange to keep caution boards for guidance of traffic during excavation work.
- v. To ensure the safety at site.
- vi. To ensure the safety of cables while back filling the trenches by proper bedding and tiling.

16. Duties of Mason :

- i. Lay precast foundation, erect distribution pillars and make foundation at site wherever required.
- ii. Fix rag bolts in walls for cutout board fixing.
- iii. Reinstatement of excavated surface in private property wherever required.

17. Duties of Sr. Painter :

- i. To paint transformers and switchgears in the DSS.
- ii. To stencil switchgears and transformers in the DSS.
- iii. To paint corroded doors of the DSS whenever required.

18. Duties of Painter Sr. :

- i. To paint Auxiliary Distribution Pillars.
- ii. To stencil ADPs.

19. Duties of Cable Inspector :

- i. To go around the section allotted and inform other utilities to take care of our exposed cables in their trenches, protecting cables from damages.
- ii. Reporting cable damages, dangerous condition of cables to his seniors.
- iii. While backfilling excavations, take care of covering the cables with proper tiles.

20. Duties of Mali:

- i. To maintain the gardens in Office & Receiving Substation premises.

21. Duties of Sr. / Jr. Nawghany :

- i. To help the jointers / fitters in their respective jobs.
- ii. To take excavation for cable laying and making jointing pits for cable joining.
- iii. Cable pulling.
- iv. Manning and cleaning of Receiving Substations & Distribution Substations and Auxiliary Distribution Pillars.
- v. Transportation of material.
- vi. To remove debris from site and transport it to the place of storage.
- vii. To maintain the cleanliness of cable /scrap yard.
- viii. To assist M.V. Driver in cleaning and maintaining the vehicle.
- ix. To draw day to day jointing material from sub stores.
- x. To bring monthly material from Main stores.
- xi. Taking scrap material to Oshiwara scrapyard..
- xii. To help the Charge Engineers in taking LV loads.
- xiii. To help the Fault Engineer in HV supply restoration.
- xiv. To help the Testing Engineer in under ground fault testing.

23. Duties of M.V. Driver :

- i. To drive the vehicle efficiently as per rules & regulations laid down by R.T.O & BEST undertaking's M.V. "ection.
- ii. To transport man and material to site / work.
- iii. To maintain the vehicle properly and to make proper entries of mileage and fuel consumed in the vehicle trip book.

24. Duties of Sepoy:

- i. To clean the Table of "A" grade Officers & Administrative Officers.
- ii. To attend bell call of "A" grade Officer & Asst. Administrative Officer.
- iii. To take out the dispatch of "A" grade Officers & concerned Administrative Section / Officers.
- iv. To carry & bring dispatch.
- v. To do any other office work delegated by Officers, Supervisor & Office Staff i.e. filing of papers, Cleaning etc.

25. Duties of Scavenger:

- i. To carry out sweeping and cleaning of Toilets of all RSS and Office Building.
- ii. To carry out cleaning of DSS yards for removing of dead Animals and Rodents.

4(b) (iii) The procedure followed in the decision making process, including channels of supervision and accountability:

Though, Divisional Engineer is the overall in charge, the dept. is divided in to sub sections under different heads. Each section is headed by an A grade officer, either Superintendent or Assistant Engineer. The Deputy Engineer is responsible for execution of the scheduled job/ break down jobs as per the decisions taken by the concerned section in charge. He is accountable for safe and proper execution of the work. There are other junior officers like Sub Engineers/Charge Engineers to assist the Deputy engineer for supervision work.

4(b)(iv): The norms set by it for the discharge of its functions:

The norms for preventive maintenance of electrical equipments are as prescribed by the Electric Supply management. The norms for breakdown maintenance are as per the guidelines from MERC which may change from time to time.

4(b) (v): The rules, regulations, manuals and records held by it or under its control or used by its employees for discharging functions:

The work is carried out as per the rules and regulations provided in Indian Electricity act 2003, Indian Electricity Rules 1956, Departmental Manual, Service regulations, Standing Orders, Safety rules etc. All the records are maintained as per the different Administrative orders and Procedure orders. All the assets are maintained in Asset Management Modules. In addition to this, the work is carried out as per the procedure orders issued by Management from time to time.

4(b)(vi): The statement of categories of documents that are held by it or under its control:
