In order to achieve minimum 10% of energy requirement from solar energy, Roof Top Solar (RTS) projects provide a clear opportunity for smart cities as they do not require pooling of land or separate transmission facilities, unlike ground mounted solar projects. The Ministry of New and Renewable Energy (MNRE) under their National Solar Mission, provides financial assistance (30% of bench mark cost or project cost whichever is less) for developing RTS projects in residential, social and institutional sectors. The details of the scheme are at Annexure I. Further, to promote RTS projects on surplus areas of all Government/PSU Buildings, MNRE has recently brought out an "Achievement-Linked Incentives and Awards" scheme (copy enclosed as Annexure II).

- MNRE has also initiated nation-wide bidding process through Solar Energy Corporation of India (SECI) for RTS projects. These will provide cost effective options for developing RTS projects in Smart Cities. Alternatively, States/Cities, if they wish, can hier B. D.D. also develop RTS projects by using model Bid Documents of SECI.

Dear Shri Sharma,

As you are aware, increasing the use of renewable energy is one of the essential features of a Smart City. All Smart Cities have to source a minimum of 10% of their energy requirements from renewable sources, including solar. One quick way of increasing solar energy use is to converge with the Roof Top Solar (RTS) project initiated by the Ministry of New and Renewable Energy (MNRE).

- 2. Unlike ground mounted solar projects, the Roof Top Solar projects do not require pooling of land or separate transmission facilities. The Ministry of New and Renewal Energy (MNRE) provides financial assistance for developing RTS projects. The details of the scheme are available on the Mission's website (www.smartcities.gov.in). Importantly, the MNRE has just brought out an incentive cum award scheme for RTS systems in Government/PSU buildings. This is an opportunity for Smart Cities to use funds provided by the MNRE to install RTS on residential, social and institutional buildings.
- 3. The MNRE has invited bids through the Solar Energy Corporation of India (SECI) for RTS projects. The Smart Cities can use the vendors procured by the SECI to ground RTS projects. Alternatively, Smart Cities can also use model Bid Documents of SECI to develop RTS projects. The Smart Cities may choose any one of the methods.
- I, therefore, urge you to operationalize the RTS projects in your Smart Cities expeditiously.

Subject: 500 MWp Grid Connected Solar Rooftop Power Plant Scheme of MNRE implemented by SECI

Madam/Sir.

As you are aware, Government of India has taken up an ambitious target of installation of 1, 00,000 MW of Solar Power by year 2022, out of which 40,000 MW is to be achieved through Roof Top Solar (RTS) Power Plants as a part of Clean Climate Commitments. Solar Cities will pay a vital role in achieving this target. The Ministry has also selected your city to be developed as a Solar City.

- 2. This Ministry has initiated major programme to support all States/UTs in developing SPV systems on rooftops and vacant spaces. Roof Top Solar (RTS) power provides a clear opportunity for using vacant roof tops of buildings for generating solar power. This can be used for reducing own demand and energy billing as also for earning revenue. RTS projects have the added advantages of minimal technical losses and of obviating need of support transmission system or land acquisition.
- 3. In this direction, to expedite commissioning of RTS projects on rooftops and vacant spaces, this Ministry had directed Solar Energy Corporation of India (SECI) to undertake competitive bidding at national level as follows:
 - (a) 500 MW tender for residential, social and institutional buildings;
 - (b) 1000 MW tender for Government and PSU buildings
- 4. The Letters of Award (LoAs) have been finalized on 28.10.2016 for 500 MWp tender (a). List of selected vendors are given in **Annexure-I**. The second national tender (b) will be taken up shortly.
- 5. Under both tenders, capacities have been allocated for all the States and UTs so that all Institutions/Universities have the option of participating in the tender. Further, both options of CAPEX Model (investments made by and project owned by roof top owner agency) and of RESCO Model (investment to be made by developer who recovers it over 25 years) are available in these tenders. In view of the economies of scale, the national level tenders should be able to ensure cost effective solutions.

- 6. You are hereby requested to kindly get the potential of RTS aggregated for the target beneficiary segment in your city and avail the services of the successful vendors selected in the competitive bidding mentioned in **Annexure-I**, for expeditious implementation of RTS projects for Government/PSUs sector, demand may be collated for inclusion in tender (b) highlighted in para 3.
